Example of client goal achievement: *I was able to facilitate an adolescent client with an acquired brain injury instructing with a full team of professionals to help him achieve his grades in his mock examinations with a view for post 16 education. I have also supported him with exploring appropriate social activities to reduce his feelings of isolation following the injury.*

Facilitating an adult client who sustained multiple traumatic injuries (including orthopaedic and multiple organ injuries) following a road traffic collision, instructing a team of professions to increase his fitness and to aid in his rehabilitation with a view of being able to access the community independently. I have also supported him and his family access psychological support in dealing with the trauma of the incident.

Supporting an adult client who sustained and acquired brain injury and orthopaedic injuries with sourcing appropriate accommodation, in order for her to live her life as independently as possible.

Additionally, I helped facilitate a young adult with an acquired brain injury to secure a placement to meet his rehabilitation needs with a view to secure appropriate long-term accommodation.
